Managing Director MSPDCI, the company inits efforts to provide reliable 24x7 power supply to the consumers, requires to achiever regular revenue reali-sation to suffice procurement of accessary power. "However, in the recent time revenue collection has gone down and it is not in consonance with the energy utilised. Unauthorised/illegal use of electricy through me-
