Installation & Commissioning

From edge switches both voice and data VLAN will be passed through a single port using Trunk/Native VLAN method and the IP telephone handset shall support Gigabit passthrough for the data port with Access/Untagged VLAN

The IP PBX shall be configured with BSNL PRI/SIP Trunk with IVRS option. Call forwarding shall be configured for reception, extension etc. Additionally direct numbers with extension mapping and boss secretary configuration shall be also configured.

Quantity may increase or decrease as per actual requirement.
