We would request you to remove the feature in the technical specifications.</p> <p>We would also request you to add BOSCH in the approved make list as it is one of the most renowned brands in conferencing.</p> <p>Sl No 4 : The main requirement for a camera is Optical zoom and digital zoom is not a criteria for image quality. We would request you to kindly reduce the Digital zoom to 12x . We would request you to kindly add Lumens as one of the approved makes.</p> <p>Sl No 5-10 - We would request you to kindly add Liberty AV as one of the approved makes.
